DESCRIPTION

The project Cilento in Tour(ism) will be implemented in the Campania Region, and in particular in one of its wildest centers, a hidden gem in the Cilento mountains, Perdifumo. The project has set itself the goal of offering to participants tools to promote their territory and understand how, from its enhancement, their professional and social redemption can arise. Through comparison with peers from different European countries that will bring similar experiences from their countries of origin, the participants will acquire, supported by a facilitator expert in the subject, marketing techniques and promotion of territorial tourism. One of the objectives of the project is to encourage the talent and entrepreneurial skills of young people from disadvantaged areas. Cilento, in fact, as a land of enormous yet unexpressed potential, becomes a privileged symbol where youngsters from different cultures can relate through interrelation, stimulate the development of their underlying capabilities.



PARTICIPANTS & THE GROUP

There will be 7 participants and 1 group leader from each partner organization. Participants should be between 18 and 24 years old. The group leader should preferably be 18+ with a stable link to the sending organization and an active role in it, preferably a youth worker or at least an experienced member.

Participants do not need to have a good knowledge in English, they just need a great willingness to be a part of a multi-cultural group.

The participants should show initiative for developing new skills, to participate to all activities and to accept to have group activities with other young people.

For the creation of an equilibrate group, all partner organizations should form gender balanced teams (4+4 including the group leaders) and to give equal chances to all applicants.

TRAVEL

It is not allowed to come to the venue of the exchange one day later or to leave one day before the designated dates. We can only reimburse tickets that are on 7th of December and on 16th of June 2021.

The participants should arrive to Agropoli Train Station until 17:30 p.m on 7th of December. We will have organized transportation from Agropoli Train Station to Perdifumo before and from Perdifumo to Agropoli Train Station after the exchange.

Don not throw any ticket or boarding pass. You will need to send all of them after the mobility. If you lose any of the tickets or boarding passes, we won't be able to reimburse you for them.

On Erasmus+ projects, there is maximum amount that can be reimbursed for the travel of participants, according to the distance from your country to the city where the project is being organized. If your tickets cost more than that amount, you are responsible for covering the difference as Erasmus+ is co-financing program.

- In exceptional cases, or exclusively in the case of technological impediments, it will be possible to fill in the paper form.
- 2. Present to the carrier, upon boarding, and to anyone appointed to carry out the checks, the "green" COVID-19 certification, issued upon completion of the vaccination cycle or equivalent certification, issued by the competent health authorities following vaccination validated by the 'EMA (European Medicines Agency).
- 3. Prove that you have undergone a molecular or antigen test, carried out with a swab and with a negative result, in the seventy-two (72) hours prior to arrival in Italy.

In the absence of the certifications in points 2 and 3 (which are cumulative, not alternatives to each other), you can still enter Italy but you are still subject to fiduciary isolation for five (5) days, and you must activate health surveillance by contacting the department prevention of the competent health care company for the area. At the end of the five (5) days of isolation, an additional molecular or antigen test is required.
